### 7.1 BASIC REQUIREMENTS

#### 1. Overriding Principles

 The Abbotsford Hospital and Cancer Centre Project will provide high quality and efficient Health Care services by taking advantage of both leading edge technology and a strategy that provides a seamless integration of clinical practice, equipment and health informatics.

## 2. Quality Requirements

 All equipment must be suitable and fit for its intended use and must be integrated with the overall design and objectives of the Project, and must meet the requirements of Schedule 17, Outline Commissioning Program, of the Project Agreement.

#### 7.2 EQUIPMENT LIST

1. General

This list, attached as an Excel spreadsheet (Equipment List AHCC Nov 04), is intended to be indicative of the project equipment requirements, the categories of equipment and the locations of equipment.

#### 2. Definition of Column Titles

1. "REF":

The REF or reference column matches the information provided in the Schedule of Accommodation for each section of the Output Specifications: Clinical and Non-Clinical Services. These numbers refer to the Alpha numeric code given to each clinical/non-clinical service (eg. C7 Surgical Services) and the associated spatial reference number.

2. "Space":

The Space column matches the spatial descriptions (eg. Operating Room) in the Schedule of Accommodation in each section of the Output Specifications, Clinical and Non-Clinical Services.

3. "Item Description"

This column provides a description for each piece of equipment. (eg. Anaesthesia, patient system).

4. "Further Description"

This column provides further detail on the equipment, as required. (eg. Mobile unit, with castors)

### 5. "Equipment Number"

Each item description has been assigned an equipment number for identification purposes. This number corresponds to the equipment number on the Equipment Data Sheets.

6. "Cat.A" to "Cat. F"
Each piece of equipment has been placed into the appropriate category,
A through to F.

7. "Quantity"

This column indicates the quantity of units required.

#### 7.3 EQUIPMENT DATA SHEETS

General

The Equipment Data Sheets, attached in Adobe Acrobat format (Equipment Data Sheets March 2004) provide the minimum acceptable performance requirements for each individual piece of equipment as it is described on the equipment list. The performance requirements are indicative of current standards of technology and anticipated project requirements.

- 2. Description of Information on Data Sheets
  - 1. "Item Description"

Each piece of equipment has been assigned an item description. This wording matches the item description found on the Equipment List.

2. "Equipment Number"

Each item description has been assigned an equipment number for identification purposes. This number corresponds to the equipment number on the equipment list.

- "Manufacturer Model Number"
   This text box provides a reference manufacturer(s) and model number(s) for the piece of equipment as it is available today.
- 4. "Recommendations must include the Manufacturer(s) and most recent version of the model number(s) listed above."

Where this text box contains an "X", Project Co must, at a minimum, include the (these manufacturer(s) and most recent version of the model number(s) in their procurement recommendations.

5. "Project Co. to meet or exceed the referenced manufacturer and Model number listed."

Where the text box contains an "X", Project Co's procurement recommendations must meet or exceed the specifications of the referenced manufacturer or model number.

## 6. "Further Description"

This text box provides a further description and detailed specifications for the manufacturer(s) and model number(s) of the equipment identified on the sheet.

## 7. "Performance Specifications"

This text box provides general performance requirements as required by Health Co.
