- B) having carefully examined the Site and all other conditions which may affect the performance of the Project Operations under the Project Agreement; and
- having satisfied ourselves as to the nature and location of the Project and the general, local and other conditions to be encountered in the performance of the Project Agreement,

hereby submit this offer ("Proposal"), which includes all of the documents identified in Section 6 herein, for the Project in accordance with the requirements of the RFP Documents (as hereinafter defined), and the following:

#### 1. **DEFINITIONS**

1.1 Unless a contrary intention is clearly indicated, terms and expressions used in this Proposal and not defined herein but which are defined in the RFP Documents shall have the meanings given to them in the RFP Documents.

#### 2. PERFORMANCE AND SCHEDULE

2.1 We agree to perform all obligations of Project Co under the Project Agreement, to the quality, in the manner specified in, and in full compliance with the RFP Documents, and

- agree to assume all obligations and liabilities imposed upon Project Co by the RFP Documents.
- 2.2 We agree to meet and achieve each and all of the Milestone Dates that are specified in Schedule 10-3 of Appendix 10 of the RFP, on or before the dates specified by us in our Proposal for those Milestone Dates.

#### 3. PRICE

- 3.1 We agree:
  - (a) To perform the Project Agreement and to accept, as full compensation therefor, the applicable Annual Service Payment specified in our Proposal.
  - (b) That the Annual Service Payment will subsequently be adjusted by Health Co to address those Options (if any) included in our Proposal and which Health Co at its sole discretion, by notice in writing, accepts within the time periods (if any) for acceptance specified in our Proposal.
  - (c) That, unless otherwise expressly stipulated in the Project Agreement, we will receive no payment or other compensation under the Project Agreement until after the Payment Commencement Date, and then only in accordance with the provisions of the Project Agreement.
- 3.2 All prices stated in our Proposal and in any submittals submitted with or incorporated into our Proposal are expressed in Canadian currency and are all-inclusive, including all Taxes save and except only GST.

- 9.2 Neither we, nor any of our partners (if we are a partnership) or any of our members (if we are a joint venture or consortium) have any interest whatsoever in the proposal of any other proponent, either directly or indirectly, and we have not entered into any formal or informal arrangement, agreement or understanding before the submission of this Proposal that would have such a result.
